### CONDITIONS OF CONSENT

1. This consent is valid only for the approved production capacity of EYE HOSPITAL.
- 2(a) . The maximum rate of emission of flue gas should not be more than the emission norms for the stacks.

- 3 . Quantity of other pollutants should also be as per the norms prescribed by the Board/MOEF & CC/or otherwise mandatory .
- 4 . The equipment for air pollution control system and monitoring ,as proposed by the industry and approved by the Board should be installed in their premises itself .
- 5 . The modification or installation in the existing pollution control equipments should be done only by prior approval of Board .
- 6 . The operation of air pollution control system and maintenance be done in such a way that the quantity of pollutants should be in accordance with the standards prescribed by the Board/MoEF & CC/or otherwise mandatory .
- 7 . Unit should do provisions for fugitive emissions chimney/stack as per the norms of the Board/MOEF & CC/or otherwise mandatory .
- 8 . The unit should submit the stack emissions monitoring report within one month from issuance of consent order along with the point wise compliance report of the consent order . Further **quarterly monitoring report should be submitted** .

#### Specific Conditions:

This Consent order is valid for M/S I CARE eye hospital and Post Graduate Institute, E-3A, Sector-26, Noida, Gautam Buddh Nagar and valid up to 31.12.2021.

2. Hospital shall ensure adequate plantation and green belt within its premises. Green cover shall be in compliance of approved map from concerned Authority.

3. Hospital shall comply with Waste Management Rules notified by MoEF & CC i.e. Plastic Waste Management Rules, 2016, Solid Waste Management Rules, 2016, Hazardous and Other Waste (Management and Transboundary) Rules, 2016 Bio Medical Waste (Management & Handelling) Rules-2016 (as applicable).

4. Hospital shall submit annual returns as per above mentioned rules. Also, Environmental Statement in prescribed form as per Rule 14 of Environment (Protection) Act, 1986.

5. Hospital shall abide by directions given by Hon'ble Supreme Court, High Court, National Green Tribunal, Central Pollution Control Board and Uttar Pradesh Pollution Control Board for protection and safeguard of environment from time to time.

6. Hospital shall make rain water harvesting on the premises as per map approved by concerned Authority. Pre and Post-monsoon maintenance of rain water harvesting pit shall be done annually.

7. Hospital has to submit balance consent (AIR) fee (IF ANY) within one month of getting this consent.
